Module summary

This module introduces English law, the legal system and the law-making process. Students are introduced to the law of contracts, the formation, acceptance and validity, and typical contract types. Students are introduced to the law of tort which deals with 'civil wrongs'. Health and safety legislation is addressed, and the role of local authorities as part of the planning process, and for the approval of building regulations. Conflict avoidance, dispute resolution and, particularly, Alternative Dispute Resolution, is provided.

Module Aims

This module aims to examine:

- An overview of the English legal system, case law (precedent) and parliament.
- The significance of law of contract and law of tort applicable to the built environment.
- The impact of public law and the impact upon the built environment, including the fundamentals of planning law and the role of local authorities.
- The importance of building safety related legislation and regulations applicable to the built environment.
- The application of conflict avoidance techniques and dispute resolution methods employed internationally across the built environment.

Module Learning Outcomes

- LO1. Demonstrate knowledge and understanding of built environment related law and legislation.
- LO2. Critically appraise a range of factual and legal material to identify logical solutions to challenges with a reasoned, professional view.
- LO3. Critically analyse complex information to demonstrate knowledge and understanding of a range of legal issues faced by built environment professionals.
- LO4. Critically appraise complex information from a range of appropriate sources, to develop reasoned alternatives.

Indicative Module Content

Module topics

- **The English legal system and sources of law for the built environment**
Outline the classification of law and sources. Outline the civil court structure, the role of parliament, legislation and case law.
- **Contracts – Formation of a valid contract and contents of a contract**
Outline the essential requirements for a binding contract offer, acceptance, intention to create legal relations and the principles of consideration. Introduction to capacity, privity, and factors which affect the validity and discharge of contract.
- **Contract procurement and contract administration**
Overview of the role of standard forms of contract utilised across the international built environment and the role of built environment related contract administration.
- **Conflict avoidance and non-court dispute resolution**
Outline conflict avoidance techniques which can be utilised to avoid disputes within the context of the international built environment context and explore the most prevalent forms of non-court dispute resolution, mandated and voluntary.

Law for the Built Environment

- **Tort – Negligence and vicarious liability**

Define a tort, duty of care, and the principles of negligence as applicable to built environment and professionals. Introduction to the duties of an occupier to visitors and trespassers, public and private nuisance and the rule in Rylands v Fletcher.

- **Public law for the built environment**

Introduction to planning law and the role of local authorities. Outline of planning legislation, policy and the role of local planning authorities in the context of the built environment.

- **Health and safety law for the built environment**

Introduction to safety related legislation, building regulations and the role of the local authority and the building safety regulator in the context of the built environment.

- **Sustainability, equality and law of organisations for the built environment**

Introduction legislation relating to sustainability, equality, law of organisations and applicable regulations in the context of the built environment

This content will be reviewed and updated regularly to reflect the legal, moral and financial changes in professional standards and practice.
